1. Human Rights & Working Conditions

• Health, Welfare and Safety.

Ethical recruiting.

ALT Internal resourcing staff comply with all relevant legislation, statutory and non-statutory requirements.

Women's rights.

ALT acknowledge that women's rights are human rights. As stated in the United Nations'1948 Universal Declaration of Human Rights, all humans are "born free and equal in dignity and rights". As such, ALT is committed to providing liberty, dignity, and equal rights to all their workers, regardless of gender.

Rights of minorities and indigenous peoples.

• Fair Working Conditions.

Working conditions, working hours and compensation are fair and comply with regulations in the country where work is performed; complying with national provisions and agreements applicable to regulating working hours, minimum wages, overtime and Leave compensation, and legally mandated benefits.

• Non-Harassment and Non-Discrimination

Conflict Minerals

As a matter of responsible sourcing, ALT Technologies will use best efforts for their suppliers not to acquire any raw materials that ALT Technologies has a reason to believe originate from the Democratic Republic of Congo or adjoining countries unless such materials are certified as "conflict free".
